Registration for the 2025 Immigration, Refugee, and Citizenship Law Moot is to be made by submitting this form to info@ilm-cpdi.ca and paying the non-refundable \$500 registration fee by November 1, 2024 at 11:59pm EST. The \$500 registration fee covers the cost of attendance for all of the events and competition in Toronto (not inclusive of accommodation) from Thursday, February 27, 2025 to Saturday, March 1, 2025 for the two appellant mooters, two respondent mooters, one optional researcher, and one coach. An additional \$100 per additional coach must be paid in order for them to attend the Moot in Toronto.
